The Defense Secretary's Misidentified Priority

According to a recent report published, the Defence Secretary, Mr. Hemasiri Fernando has invited expatriate Tamils or Tamil diaspora to contact the Defence Ministry and to report about the credible atrocities committed by Sri Lankan security forces. This is indeed a strange attempt as the majority of vocal members of "the expatriate Tamil community" have been highly critical of Sri Lanka's defence forces for having stopped the Tamil eelam dream of the LTTE Tamil terrorists at Nandikadal lagoon. Therefore, the response, if any to the Defence Secretary's clarion call will only result in further complications with obviously biased inputs.

It is common knowledge that there is a substantial yet many questionable and some fabricated published reports which had been submitted by the pro-LTTE expatriate Tamils to the UNHCR and by other well-known NGOs and also to Western Governments which the Defence Secretary have ready access to. He should go through these reports and start first to consider to separate the facts from the fiction and to take action, if required. 
At the same time we draw your attention to the documents such as the Census details of 2008/9/10, LLRC conclusions, Re-Appraisal report to OISL prepared by Sir Desmond De Silva, Prof D.M. Crane and Sir Geoffrey Nice and other also authentic reports

Further, there are detailed article by Kath Noble, Dr Delgoda- Tammita and Dr Micheal Roberts disproving the 'numbers' of the Tamil civilians said to have been killed'. If the defence secretary decides to comb out the issues he will realize that the members of our defence forces have gone that extra mile to protect tens of thousands of civilian lives in overcoming the Tamil terrorist LTTE rather than engaging themselves in atrocities.
